All horses shall pay \$2,000 to pass the entry box and \$3,000 additional to start, with \$300,000 Guaranteed, with \$180,000 to the winner, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. 120 lbs. This races will not be divided. If the number of entries exceed the starting gate capacity, preference will be given to those horses with the highest total earnings and an also eligible list will be drawn. Failure to draw into this races at scratch time cancels all fees. A trophy will be presented to the winning owner, trainer and jockey. Starters to be named through the entry box by the closing time of entries.
