For horses not nominated, supplementary nominations of \$10,000 each will close at the time of entry for the race during the Los Alamitos Winter Thoroughbred Meet. All horses shall pay \$2,000 to pass the entry box and \$3,000 additional to start, with \$300,000 Guaranteed of which \$180,000 to first, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. 120 pounds. This race will not be divided. If the number of horses exceed the starting gate capacity, preference will be given to those horses with the highest total earnings and an also-eligible list will be drawn. Failure to draw into this race at scratch cancels all fees. A trophy will be given to the winning owner, trainer and jockey. Starters to be named through the entry box by closing time of entries.

No stable reservation or entry in any race will be received except upon the condition that all disputes, claims and objections arising out of the racing or with respect to the interpretation of any rules or conditions of races or otherwise shall be decided by the California Horse Racing Board, the stewards of the meeting, or Los Alamitos Racing Association, and such decisions upon all points shall be final.

In all stakes, acceptances must be made through the entry box, at the usual time of closing of entries.

Los Alamitos Thoroughbred Racing Association reserves the right to cancel any stake or other race prior to the actual running thereof, without liability except for the return of nomination and entrance fees paid to the owners of the eligible horses at the time of cancellation, and to the owners at the time of forfeit on horses on horses which have not been kept eligible.

Los Alamitos Thoroughbred Racing Association will in no event be considered to have responsibility for the care, custody or control of horses kept at Los Alamitos Race Course or elsewhere. Applicant assumes full responsibility for the safety and well-being of all horses stabled by applicant at Los Alamitos Race Course, and agrees to take all reasonable measures for the protection of such horses, including providing adequate supervision for such animals while on the premises, hiring competent personnel to care for such animals at all times, cleaning and maintaining stalls assigned pursuant to this application and removing any hazardous condition from such stalls which is known to applicant or applicant's employees, or if applicant believes that such condition should be remedied by Los Alamitos Thoroughbred Racing Association, promptly call attention to the attention of Los Alamitos Thoroughbred Racing Association in writing, any such hazardous conditions. Applicant further agrees to properly supervise all applicant's employees, agents, their express invitees, and other persons known to them to be in the area assigned to them pursuant to this application, and hereby acknowledges that they are responsible for the conduct of their employees, agents and express invitees, and that Los Alamitos Thoroughbred Racing Association has no obligation to remedy any conditions on the track premises which may be caused by the negligence of or willful conduct of any such employees, agents or express invitees, unless it has prior written notice of the existence of such condition and has had a reasonable opportunity to repair such condition.
